FSG Colour Edging Pens

Application

- For opaque dyeing of closed surfaces made of wood, plastic and metal.
- For fast, easy colouring of corners, edges and grooves.
- For painting guide grooves on foil laminated PVC window profiles and doors.
- For indoor and outdoor use.

Characteristics

- Acrylic-based pigmented topcoat.
- Fast drying
- High opacity
- Good adhesion to many lacquer, plastic and metal surfaces.
- Good lightfastness and weathering resistance (with corresponding layer thickness)

Instructions for Use

- Shake for at least 30 sec with closed cap (mixing balls must be audible)
- Remove the cap. Put the tip on solid ground and press it down (pump) 10-15 times, until it is saturated with colour.
- Wait after initial activation of the tip about 30 sec., so that the tip is fully soaked with lacquer.
- If a pen has not been used for a longer time, replace the tip. The old tip does not ensure optimum paint flow anymore, as it holds sedimentations.
- Test the colour accuracy of FSG-Edging touch-up Pens after the paint is dry (about 2 min. after application).
 Important: Close immediately after use – to prevent desiccation!
